		 Sharon Green – stated she thinks the Committee did an amazing job of dissecting and putting policies back together to make sure each area was covered. Sharon Green – opened for motion to approve and any discussion Asked Committee to go back and review, specifically pages 10 and 15 (Committee's potion starts) Mentioned a lot of detail was added to ensure there are no discrepancies about what is supposed to be happening with the CES and outreach. Stated a portion/piece about complaints was added, which includes an element that when there is a complaint for instance from the high desert region, Sharon Green being from the high desert will not participate so that it is a fair process, with no preferential treatment or bias to ensure the complaint is taken seriously as it impacts the county and people being served. Shared that before starting this process, there were several complaints, specifically one about her, and how it went to the appropriate agency and had to go through a process of answering questions to resident and Federal Business Bureau. William Lamas – mentioned it was a huge process to review and assess previous policies Sharon Green – provided opportunity for comments after motion of approval. Kameron Grosvenor – mentioned she thinks they have a good working document and excited to see implementation of it, and getting all different agencies on board and ensure they are following it William Lamas – agreed with Kameron Grosvenor and stated this is a living document so as CoC grows and with different changes from the State/Federal there will be an opportunity to review and will be reviewing regularly Aziza Manual - mentioned her goal is to eliminate barriers that providers have with not understanding the process, and if providers feel supported by having ISCUW 211+ available, the barr

Discuss the formation of a new Ad-Hoc Committee to evaluate regulatory compliance from participating agencies	Sharon Green, Chair	The Chair opened discussion on forming an Ad-Hoc Committee to evaluate regulatory compliance from participating agencies. Sharon Green – mentioned as Chair of Homeless Provider Network (HPN) has positioned themselves as taking money away, but don't really check what is going on in the field and so this Ad-Hoc Committee is really to evaluate what is happening with the providers Mentioned this effort would hold agencies accountable and gives training when training is needed, and when reports are received that one is going out and investigating. Stated it is time for providers to step up and make sure everyone is effective. Sharon Green - Requested to start with discussion of participating agencies that should be on this Ad-Hoc. Kameron Grosvenor – asked if would just be looking at coordinated entry matters or confused on scope of work of Ad-Hoc. Sharon Green - responded this Ad-Hoc is making sure everyone is accountable for excellence and ensured providers are structured properly that if there is a problem, the Ad-Hoc will help navigate to make sure provider is effectively providing services and housing; will be reviewing not only CES, but also outreach William Lamas - stated will just be an assessment of organizations using CES and providing outreach to ensure they are providing the services they are intended to provide as this discussion came from HHAP recipients and questioning their services and responsibilities; this will be a review of programs that are funded. Sharon Green - stated this review will help providers prepare for the monitoring and evaluations were money is being discussed or removed. Kameron Grosvenor - mentioned being qualified to monitor on coordinated entry, but concerned about monitoring other agencies as she does not know enough about Permanent Supportive Housing (PSH) so would not feel comfortable going out to assess PSH as this would be something OHS may do and wants to ensure the Ad-Hoc does not overstep their bounds more than they are ready to. Aziza Manual - stated that supp
		many/recommendations of which individuals to be on Ad-Hoc and standards of goals (scope of work), and bring this back to the next CES Committee meeting; confirmed Ad-Hoc would provide progress of providers

	 Melanie Gonzalez Ganceda – responded that it is up to the CES Committee if they would like providers included in the Ad-Hoc. Kameron Grosvenor – anticipates meeting with OHS and ISCUW 211+ to discuss what individuals include and standards to brainstorm before the next CES Committee meeting; suggests for Ad-Hoc to include maybe one/two representatives from CES Committee, ICH, ISCUW 211+, outreach component (Mike Jones), and OHS (Melanie Gonzalez Ganceda). Sharon Green – requested Marcus Dillard's opinion on this. Marcus Dillard – informed OHS started the best practices based on community meetings that have been held; loves idea of having an Ad-Hoc to support the providers needs, but need to make sure we are following the standards based on the funding to provide good advice; this can be accomplished by having a collaboration between OHS and this Ad-Hoc. Sharon Green – recommends in moving this discussion to the next CES meeting agenda. A motion was made by William Llamas seconded by Astrid Johnson. 2 members were in favor: Sharon Green, Kameron Grosvenor 0 members were opposed.
