LEGAL AUTHORITY

AB 210 / WIC 18999.8

- Chaptered Oct. 7, 2017 — Chapter 544, Statutes of 2017
- Authorizes counties to form MDTs to expedite identification, assessment, and linkage to housing/supportive services, and permits participating agencies to share confidential info under California law to coordinate care.

AB 728 / WIC 18999.81

- Chaptered Sept. 26, 2019 — Chapter 337, Statutes of 2019
- Adds explicit focus on people at risk of homelessness and prevention.

Assembly Bill No. 210

CHAPTER 544

An act to add Chapter 18 (commencing with Section 18999.8) to Part 6 of Division 9 of the Welfare and Institutions Code, relating to public social services.

[Approved by Governor October 7, 2017. Filed with Secretary of State October 7, 2017.]

LEGISLATIVE COUNSEL'S DIGEST

AB 210, Santiago, Homeless multidisciplinary personnel team. Existing law authorizes counties to establish a child abuse multidisciplinary personnel team, as defined, to allow provider agencies to share confidential information in order to investigate reports of suspected child abuse or neglect or for the purpose of child welfare agencies making detention determinations, as specified.

This bill would authorize counties to also establish a homeless adult and family multidisciplinary personnel team, as defined, with the goal of facilitating the expedited identification, assessment, and linkage of homeless individuals to housing and supportive services within that county and to allow provider agencies to share confidential information, as specified, for the purpose of coordinating housing and supportive services to ensure continuity of care. The bill would require the sharing of information permitted under these provisions to be governed by protocols developed in each county, as specified, and would require each county to provide a copy of its protocols to the State Department of Social Services.

This bill would authorize the homeless adult and family multidisciplinary personnel team to designate qualified persons to be a member of the team for a particular case and would require every member who receives information or records regarding adults and families in his or her capacity as a member of the team to be under the same privacy and confidentiality obligations and subject to the same confidentiality penalties as the person disclosing or providing the information or records. The bill would also require the information or records to be maintained in a manner that ensures the maximum protection of privacy and confidentiality rights.

The people of the State of California do enact as follows:

SECTION 1. Chapter 18 (commencing with Section 18999.8) is added to Part 6 of Division 9 of the Welfare and Institutions Code, to read:




INFORMATION SHARING

What can be shared

- Confidential info under California law may be exchanged if reasonably believed relevant to reducing/eliminating homelessness or providing services
- Law enforcement use is limited to identification/assistance/ linkage (not enforcement purposes).

Shared information must be purpose-limited, compliant, and protected.





HOMELESSNESS MDT

- The County Administrative Office established the Homeless Multidisciplinary Team (MDT) in February 2025.

Within the past year, U.S. VETS Inland Empire made significant and positive impacts utilizing their increase in grant funding to bridge various gaps in services to veterans dealing with homelessness in San Bernardino County.

The CA-609 San Bernardino City and County Continuum of Care (CoC) strives to develop countywide partnerships that coordinates services directed towards reducing and preventing veteran homelessness by providing comprehensive services. Update – HUD 2025 Continuum of Care Notice of Funding Opportunity

Receive an update on the U.S. Department of Housing and Urban Development (HUD) Continuum of Care (CoC) Notice of Funding Opportunity (NOFO)

HUD administers the CoC Program to support local and regional efforts to address homelessness through coordinated housing and supportive services. Each year, HUD issues a NOFO that sets the requirements, eligibility rules, submission process, and scoring criteria for CoC funding. The NOFO governs how CoCs (1) apply for funding through HUD's e-snaps system, (2) prioritize and rank renewal and new projects, and (3) submit the CoC's required application components (including project listings and other CoC-level materials).

HUD's approach for FY 2024–FY 2025 was structured around a two-year framework that, in general, contemplated FY 2025 eligibility and funding decisions being based on the FY 2024 submission for projects meeting specified criteria (i.e., projects could be carried forward without a separate, duplicative renewal submission for FY 2025 under certain conditions).

On November 13, 2025, HUD issued a separate FY 2025 CoC NOFO that substantially changed the competition structure and timelines compared to the FY 2024–FY 2025 framework, including creating a more compressed planning and submission window for CoCs. For the FY 2025 competition cycle, the FY 2025 NOFO functionally superseded the prior FY 2024–FY 2025 framework for purposes of FY 2025 competition requirements. The FY 2025 NOFO also made major changes to the traditional tiering and permanent supportive housing funding approach.

Following issuance, the FY 2025 NOFO became the subject of litigation and related court action affecting HUD's implementation. HUD subsequently withdrew the FY 2025 CoC NOFO on December 8, 2025. In addition, a federal court issued an injunction on December 19, 2025 that affected HUD's implementation approach for the FY 2025 CoC NOFO. On **January 8, 2026**, HUD notified CoCs of its intended approach consistent with the court's order and announced that the FY 2024–25 NOFO would reopen beginning **January 9, 2026**, with a submission deadline of **February 9, 2026**.

At this time, the CoC's portfolio consists of renewal projects. Under the applicable FY 2024–FY 2025 NOFO framework, renewal projects may not be required to submit a separate FY 2025 renewal application (subject to meeting HUD's criteria and confirmation of the correct submission steps in e-snaps), and a consolidated FY 2025 competition-style submission may not be required for renewal-only scenarios. To ensure full compliance and to maintain continuity of funding for currently funded
