This includes a 36% increase for OHS. He introduced Lola Alvarez, an intern with Supervisor Rowe's Office. Wednesday, June 25, 2025, at 5:00pm Land Use Services is hosting a Open House in Joshua Tree at the Bob Burke Government Office, all departments will be available to answer questions.</li> <li>Co-Chair Stone James said that the City of Twentynine Palms City Council will be potentially creating a council subcommittee for their housing and homelessness committee at their next meeting Tuesday, June 24, 2025. He shared Point in Time Count data from 2016-2025.</li> </ul>

CONSENT ITEMS	PRESENTER	<ul> <li>Board Member Lakita Johnson gave an update on Molding Hearts, they have a contract with the Department of Behavioral Heath as well as Mental Health and Drug Court. If an individual is on Suboxone they can house them with the criteria that their medication is locked up and they self-administer. They are collaborating with Valley Star to house homeless individuals ages 18 – 25(transitional age youth) for free up to one year. They have a new contract with DBH called 24/7 which allows the sheriff to call at any time to house a homeless individuals, with a daily rate for housing and transportation.</li> <li>Janet Johnston said she attended the following: the May Continuum of Care Membership meeting, May 30th Simba Center Landlord event, Reach Out's National Innovative Communities Conference on June 3rd &amp; 4th, Victorville Wellness Center tour on Wednesday. The Wellness Center houses over 159 people and provides complete wraparound services. They have street outreach teams that focus on case management, health and ensuring people are safe. The team continues to work with people in the field. The next Working Group meeting is Monday 9:30 am – 11am at the Joshua Tree Community Center, Dr. Mario Rocha from Inroads will present.</li> <li>Co-Chair Robin Schlosser thanked Reach Out Yucca Valley for their Shower Event. H. Inland Housing Solutions, Marisela Manzo	Marisela Manzo, Community Engagement Director	Marisela Manzo, Community Engagement Director, provided a detailed presentation on Inland housing Solutions and program overview on Rapid Re-housing (RRH), short/medium-term rental subsidized housing program. Serves families with children in San Bernardino County. Provides four layers of services including Housing Navigation, Case Management, Rental Cost and Move in cost on a case by case. It is funded by Housing Urban Development (HUD) directly and it is Federal funds.  Questions from the Board.  • Board Member Curtis Yakimow asked the Co-Chairs of the EDRSC Board if any additional information or guidance has been provided by OHS in regard to HHAP 4 Funding. Because the information provided on the agenda seems to be a little different than what is provided by IHS in terms of residual funding.  • Co-Chair Stone James shared the following, the contingency plan for the East Valley evaluators for the HHAP 4 was to distribute the funding equally among the recommended agencies. IHS HHAP 4 funding remains under negotiation and OHS is meeting with IHS on May 19, 2025, to further discuss the contract. The COC board will make the final decision.  • Co-Chair Robin Schlosser said that it is her understanding that OHS could not move forward until negotiations with IHS are complete. She asked the presenter to provide a copy of her presentation so it can be shared with all board members.  • Board Member Janet Johnston expressed concern in regard to when HHAP 4 item be placed on the COC board agenda.  • Board Member April Ramirez asked if IHS can provide street outreach and if they are willing to work with sub-contractors. She also asked if a representative can be present at future meetings.

#### **Proposition 63 – Mental Health Services Act**

- In November 2004, California voters passed Mental Health Services Act (MHSA) Proposition 63, which imposes a 1% tax on adjusted annual income over \$1,000,000
- The intent of the MHSA is to expand mental health services to reduce the long-term adverse impact on individuals, families and state and local budgets resulting from untreated serious mental illness
- Prevention and Early Intervention (PEI) is specifically intended to address mental health issues early on, reducing risk factors and/or addressing early symptoms for timely access to care and supports.
- The Family Resource Center and the Military Services & Family Support program are PEI programs.

#### ASKING ARTIFICIAL INTELLIGENCE TO EXPLAIN CONFLICTS OF INTEREST....

#### **Actual vs. Perceived Conflict of Interest**

#### **Actual Conflict of Interest**

An actual conflict of interest occurs when a person has a direct and real conflict between their official duties and their personal interests. This means that their personal interest does or will improperly influence their decisions or actions in a professional role.

#### Example:

A city council member votes to award a contract to a company they secretly co-own. Their personal financial interest is directly involved in the decision.

#### Perceived (or Apparent) Conflict of Interest

A perceived conflict of interest arises when a situation appears to an outside observer to involve a conflict, even if no improper influence or wrongdoing actually exists. The key here is public perception, not the reality of the conflict.

#### Example:

That same council member votes to award a contract to a company where their sibling works. Even if the council member has no financial interest and acted ethically, the public might perceive bias due to the family connection.

- Why the Distinction Matters...
- Actual conflicts can lead to legal or ethical violations and consequences.
- Perceived conflicts can damage public trust, even if no rules were technically broken.

Both types should be addressed seriously-actual conflicts must be avoided, and perceived conflicts should be disclosed and managed transparently to maintain integrity and credibility.






# TO SPOT THE SIGNS OF A STROKE,



#### Balance: Loss of balance or coordination.





#### Eyes: Changes in vision.



Face: Drooping features on one side of the face.



Arms (and legs): Weakness in a limb.



Speech: Difficulty speaking or understanding others.



Time: Call 911 or emergency services right away.

# Inland Housing Solutions





# **History**

In 1988 Inland Temporary Homes (ITH) was incorporated in California.

**Early Operations:** We began in a restored farmhouse in Loma Linda, providing initial steps for homeless families toward self-sufficiency. In 1991 we officially opened as a 30-day homeless shelter with minimal services.

**Growth and Expansion:** In 1998 we expanded shelter stay to 90 days, offering a full range of supportive services. Then in 2007 we added 16 housing units through the Infinite Horizons Transitional Housing program, supporting families toward stability.

## History

2013

In 2013 we Launched the first Rapid Rehousing (RRH) services, helping families with children move quickly to permanent housing.



2022

Secured contract with Inland Empire Health Plan (IEHP) for housing-related services under the Cal AIM initiative.



2024

Department of Aging and Adult Services (DAAS)- At Home Project under Adult Protective Services (APS)

\*\*Rebranding\*\*: In 2016 we changed name from Inland Temporary Homes to Inland Housing Solutions (IHS) to reflect our new service model and expanded services.

# Infinite Horizon-Rapid Re-housing



#### **Program Overview:**

It is a Rapid Re-housing (RRH), short/medium-term rental subsidized housing program. Serves families with children in San Bernadino County. Provides 4 layers of services to include Housing Navigation, Case Management, Rental Cost and Move in cost on a case by case. It is funded by Housing Urban Development (HUD) directly and it is Federal funds.


- Services: Rapid Re-housing Housing Navigation, move-in costs, short- to medium-term rental assistance, case management
- Note: There are no income requirements. However, a family must be able to increase income as they will be responsible for their entire rent after assistance ends.

- Family must be <u>literally homeless</u> (coming directly from an emergency shelter, hotel/motel paid for by a third party, or place not meant for human habitation),
  - Currently living in <u>San Bernardino</u> <u>County</u>, AND
- Have at least one <u>child</u> age 17 or younger in their custody or pregnant to qualify
- Referral must come from CES- Coordinated Entry System

Call 2-1-1 for access to CES

Once we receive a referral it takes up to 72 hours (3 business Days) to reach out





# **Community Supports**

The Departments of Health Care Services (DHCS) encourages Managed Care Plans (MCPs) such as IEHP to offer a robust menu of 14 Community Supports Services (preapproved by DHCS) to comprehensively address the needs of Members including those with the most complex challenges affecting health such as:

- Homelessness
- Unstable and unsafe housing
- Food insecurity
- Other social needs
- A key goal of Community Supports is to allow Members to obtain care in the least restrictive setting possible and to keep them in the community as medically appropriate.
- Community Supports are optional but STRONGLY encouraged.
- Members are not required to use Community Supports.



# **Environmental Accessibility Adaptations (Home Modifications)**

Home Modification: Limits apply

- Ramps and grab-bars to assist Members in accessing the home;
- Doorway widening for Members who require a wheelchair;
- Stair lifts;
- Making a bathroom and shower wheelchair accessible (e.g., constructing a roll-in shower).
- Installation of specialized electric and plumbing systems that are necessary to accommodate the medical equipment and supplies of the Member; and
- Installation and testing of a Personal Emergency Response System (PERS) for Members who are alone for significant parts of the day without a caregiver and who otherwise require routine supervision. (Financial Assistance)



# Housing Transition Navigation Services & Housing Tenancy & Sustaining Services



Housing Transition Navigation Services (HTNS): Housing transition services assist members with obtaining housing.

Equivalent to Housing Navigation to identify housing options affordable to members referred in a permanent housing setting

\*\*No Financial Assistance\*\*



Housing Tenancy & Sustaining Services (HTSS): This service provides tenancy and sustaining services, with a goal of maintaining safe and stable tenancy once housing is secured.

Equivalent to Case Management once they are housed helping them connect to local resources and budget to maintain their housing

# Housing Deposits

#### **Housing Deposits: Limits**

- Housing Deposits assist with identifying, coordinating, securing, or funding onetime services and modifications necessary to enable a person to establish a basic household that do not constitute room and board.
- Move-in Cost: Example: Security Deposit and, First month's Rents (Financial Assistance)

# **Turn Around Times**

IEHP Turn-around time is

5-7 days from their
intake to determination
and send the
Authorization.

Once we received the Authorization it takes 3 to 5 Days for IHS to make contact and coordinate services.



**Recommendation:** It is a one-time assistance highly recommend to encourage members to start looking for units or increasing their income while the process takes its course.

- Individuals that are currently receiving Community Supports are highly likely to qualify for ECM



#### What ECM Includes

ECM adds an extra layer of support without changing any of your current Medi-Cal benefits. You'll keep your existing doctors and providers, plus you also get help to:

- Find Doctors & Schedule Appointments: We help you find the right doctors for all your health needs and make sure you get the appointments you need.
- Manage Your Medications: We assist in understanding and managing your prescriptions to ensure your treatment is effective and safe.
- ► Arrange Transportation: Need help getting to your doctor visits? We can arrange transportation for you.
- ► **Get Follow-Up Care:** After a hospital stay, we help arrange the necessary follow-up services to aid your recovery.
- Connect to Local Resources: From food assistance to other social services, we connect you to the resources your are eligible for and are available in your community.
- **Support You and Your Family:** We provide educational resources and support to you and your family, including caregivers and guardians.



# East Valley Numbers for 2024




