Inland Equity Community Land Trust - Plan Adelanto	Jeff Green and Maribel Nunez, with Inland Equity Community Land Trust (IECLT)	<p>Chair recognized Jeff Green and Maribel Nunez, with Inland Equity Community Land Trust (IECLT) to provide presentation on Inland Equity Community Land Trust - Plan Adelanto</p> <ul style="list-style-type: none"> • Jeff and Maribel provide the committee and attendees with a handout on IECLT and its Adelanto project under development. • IECLT was formed as a non-profit in 2020. • IECLT exists as a unique model creating affordable housing. • IECLT has access to 20 acres of unincorporated property located in Adelanto and is grateful to the support of Juan Carillo's office for a \$1 million grant supporting the project named Plan Adelanto. • Plan Adelanto plans to build five (5) houses on five (5) acres for a total of sixteen (16 units) with shared water and solar power. • When completed, the 1,080 sq foot homes will be available for sale to eligible buyers meeting a 120% of the San Bernardino County Area Median Income (AMI) (\$103,900) threshold and estimated sale price is \$270,000. • Jeff answers questions from attendees that homes will be FHA approved for financing with a 3% down payment. IECLT will buy down a portion of the home price and retain a 20% equity. The homeowner retains 80% equity. Jeff reports working with Banner Bank on financing. An eligible buyer will need approximately \$6,000 as a deposit. • Jeff reports the first home should be ready for sale in early 2026 and promises to update the committee on the Plan Adelanto progress. Center		<ul style="list-style-type: none"> Kevin Mahany reports that Symba, the nonprofit operator of the City of Victorville's 170 bed Wellness Center has achieved national certification of its recuperative care health program one of 28 in the country and the first in the Inland Empire. The certification is provided by National Healthcare for the Homeless Council. Certification is awarded to providers reported as improving the health and housing of persons who are homeless. Since opening in December 2023, the Wellness Center has graduated over 200 homeless adults into housing or family reunification. To learn more about the certification visit: https://nhchc.org/medical-respite/nimrc/certification/ Symba reports its recuperative care program is supporting referrals from local hospitals and Medi-Cal health plan Inland Empire Health Plan (IEHP). The Wellness Center reports they have a waiting list of homeless adults and families wanting admission and that nonprofit partners and the City of Victorville are assisting them to identify rapid rehousing resources to place graduates
